Introduction

Recent input from the Donor Council and assessments of CEPF have led the Secretariat to develop a plan for enhancing CEPF's monitoring system.

Background

 The 2006 evaluation of the fund performed by Michael Wells recommended that CEPF improve its impact monitoring, while recognizing that the Fund has made concerted efforts to report on performance.

"While worthy efforts have been made, the overall efforts to monitor impacts and progress have not been not particularly convincing so far" (Michael Wells, 2006)

- The evaluation also recommended that the impact monitoring system should cost effectively
 demonstrate how CEPF is achieving conservation, development and capacity-building impact,
 recognizing that these outcomes are well beyond the scope of five-year investment periods.
 - "(...) the use of conservation outcomes as long-term operational targets should be complemented by the development and adoption of socioeconomic, political and civil society measures and indicators that will provide more feedback on CEPF's interim progress towards these outcomes." (Michael Wells, 2006)
- In 2007, CEPF developed its strategic framework to "set out the vision for FY 2008-2012," and specifically to "expand the program's potential to act as a mechanism for the conservation community as a whole to align conservation investments for greater impact by among other things an 'improved monitoring and learning to demonstrate biodiversity impact and enable adaptive management and replication."
- Moreover, the strategic framework proposed strengthening monitoring and evaluation at the
 ecosystem level including systematic analyses and documentation of CEPF results and
 experiences. The framework proposed specific conservation targets and indicators to be
 developed as part of the ecosystem profiles for each hotspot. Additionally a selected set of
 indicators would report on global results at the midterm and end of investment periods.

- The strategic framework includes a set of outcomes and targets that the fund should be reporting on. Per the strategic framework, RITs are responsible for collecting the ecosystem-level data and the Secretariat conducts the analysis. July 2010 was the first time that the Secretariat received reports from the RITs on these targets and indicators.
- More recently, the assessment performed by Conservation International's Science and
 Knowledge Division that was presented in Nagoya in October 2010 emphasized the need to
 improve the monitoring system of CEPF to ensure that the program can report on results that are
 attributable to our investment and not just products to which CEPF contributed.
- Donor Council members, particularly those representing the Government of Japan, have encouraged the development of a stronger monitoring system. The Government of Japan is suggesting specific impact indicators as part of the negotiation of the financing agreement of the replenishment of the grant.

Objective

Develop a cost-effective monitoring system for CEPF to track and report on its impact, complementing the indicators approved for the 2008-2012 Strategic Framework.
