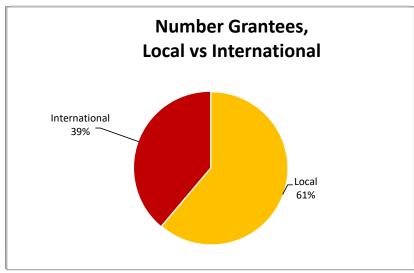

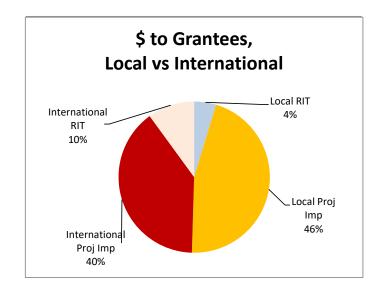


# CEPF Phase II & III Grant Portfolio as of 09/30/24

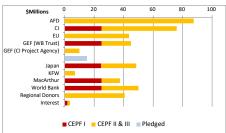

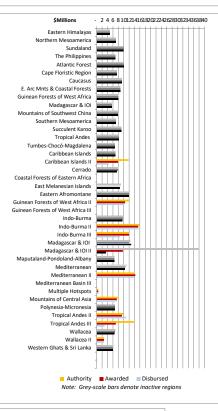

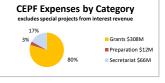
