8. Summary of the project.

Promote conservation of Mt. Mabu forest area via six components per full proposal to CEPF, including establishment of forest as conservation area, establishment of a community based organization, production of a land-use plan, production of an integrated management plan, and establishment of a field research centre. In particular, CEPF will support the rehabilitation of derelict building on an abandoned tea estate and turn it into a research centre.

10. Status of area to be impacted: This section should describe the applicant's understanding of the site.

The existing Cha Madal tea estate, an area of approximately \_\_\_\_\_hectares, was developed in the early 1900s and abandoned over thirty years ago. The tea estate has several derelict buildings on it. Mozambique Holdings has purchased the estate and intends to rehabilitate it to productive status. Mozambique Holdings intends to sell or lease one of the buildings to FFI and its partner, Justica Ambiental!, which will in turn restore the building. The expected building to be leased is approximately 500 square meters. The building sits on already-developed land within the tea estate. There will be no new construction, land clearing, or expansion of the developed footprint.

11. <u>Approach</u>: This section will describe proposed actions during the project. Specifically, what do you intend to do and how will you do it?

Note that this is provisional. Detailed estimates and plans will not occur until the project begins. Anticipated rehabilitation includes multiple items related to restoration of an existing building, including: structural, electric, plumbing, paint.

There is no anticipated negative impact. Work will take place on the existing tea estate footprint. Access to the site will be via existing roads. Work will be contracted and conducted locally.

No mitigation measures are anticipated beyond following Mozambique building codes. These include proper plumbing and handling of water-borne waste, proper installation of electric and other wires through adjacent areas, and proper handling of solid and liquid waste during construction/rehabilitation.

FFI and JA! will engage a sub-contractor to implement the actual rehabilitation of the building. The sub-contractor will follow all local law and due diligence regarding occupational health and safety, including training of personnel, provision of proper equipment and safety gear, and access to first aid or medical care if necessary.
