7. Introduction:

The project will provide an innovative model for biodiversity preservation, based on (1) the community management of protected areas to increase the production of Oku White Honey and on (2) the development of markets for finished products benefiting to the local populations living in and around high biodiversity areas. The project aims to validate this approach on Mount Oku biodiversity conservation through the regeneration of degraded forest biodiversity with native bee loving and economic trees, which will help increase the quantity of honey produced. The project will also strengthen the Oku White Honey value chain by improving the quality of the finished products and developing robust markets. This program will help organize bee farmers, lead to job creation and increase the revenue of the local population. The development of this green value chain will reduce pressure on natural resources, encourage communities to support conservation effort, build capacity among community leaders including women and improve the livelihood of the population.

<u>Project main objective:</u> Foster sustainable livelihood and job creation activities for local communities as incentives for the Mount Oku conservation.

This project is in line with Strategic Direction 1 and investment priority 1.3 where livelihood improving opportunities are developed for forest communities like apiculture, agroforestry and forest product value chain development for job creation and income generation. This gives livelihood opportunities to forest people that make them value their forest and see the need to protect it because of the forest economic returns to them. CAMGEW will work to increase honey production and marketing. More bee forage trees will be planted in the forest and forest people trained in apiculture (job creation) and provided with production materials. The sale of the finished products will be improved through packaging, labeling and marketing, aiming at increasing the income generation.

CAMGEW has been working with Mount Oku forest population since 2010 on project execution and studies. CAMGEW worked with these people under the World Bank Development Market Place competition forest governance project from 2011 to ending 2012. CAMGEW has also worked with these partners through the French Facility for Global Environment (FFEM-PPI) forest project from 2013 to 2016 (PPI3 and PPI4). CAMGEW has just received PPI5 grant in July 2017 to continue their work and improve forest governance in Mount Oku.

CAMGEW's role is to make sure that livelihoods of forest people are improved and the Mount Oku forest sustained. CAMGEW team lives in the community, hold meetings with forest people, listen to their needs and observe which activities need to be implemented to improve their livelihood and protect the biodiversity. CAMGEW always consults with the local population to get their perspectives and use it to develop projects. Through this work CAMGEW identified forest people needs through interviews, questions asked during trainings, monitoring and evaluation processes or sessions of projects. The support

of the research students engaged with the local population also helps CAMGEW to develop impactful projects.

Since 2015, CAMGEW and Man and Nature have been developing the Oku White Honey and bees wax green value chain together with the community and organizing bee farmers into cooperatives. Through meetings and working sessions they have requested for more support to increase production, increase quality and improve honey and bees wax marketing.

14. Resources and Responsibilities:
