- 8. **Introduction:** Saola may be the most endangered mammal in the Indo-Burma region. In the twenty-nine years since the species' scientific discovery, improvements in *in situ* protection efforts in its range have not overcome parallel increases in exploitation pressure. Today there is yet no site in the Annamites where any subpopulation of Saola is secure from poaching, and the situation is now critical. Consequently, the IUCN Saola Working Group has embraced and endorsed the IUCN "One Plan Approach" as the only hope for saving Saola. For a highly endangered species, the One Plan Approach integrates long-term *in situ* protection of a species' habitat with an essential conservation breeding program aimed to stabilize and rebuild the remaining population while there is still time. The long-term goal of the Saola One Plan Approach is one or more viable populations of Saola living securely in the wild in the Annamite Mountains.

A first, essential step of the Saola One Plan Approach is to find remaining Saolas in the wild. The technical team of the Saola Foundation estimates that only about 10% of the effort needed to find the last Saolas has thus far been deployed. In the next few years, the Saola Foundation will work to fill this critical gap in effort, through a comprehensive, all-out search based in the best science and state-of-the-art methods. CEPF's support will be crucial to getting the program started. Without such a search, saving Saola through the One Plan Approach will not be possible, and the species will continue its present arc toward near-term extinction.

Even if our project's comprehensive search fails to find Saola, it will have significant conservation benefits for many other threatened species of the Annamites, and potentially beyond. What we learn in the course of this program, and its CEPF-supported components, will be applicable to finding – and thus protecting - other rare species.

Specifically, the CEPF-funded portion of our search program will cover these three components:

- 1. Development of tools to rapidly test samples in the field for Saola DNA.
- 2. Development of a highly trained, effective detection dog team in Lao PDR (to search for, e.g., Saola dung for rapid DNA testing).
- 3. Development with the Government of Lao PDR (GoL) a Memorandum of Understanding (MoU) for the intensive Saola search program.

## 10. Summary of Previous Stakeholder Engagement Activities:

The Saola Foundation for Annamite Mountains Conservation is a new organization, launched in September 2020. Travel restrictions due to the Covid-19 pandemic have hampered our ability to engage

with stakeholders since our public launch. Fortunately, this has been somewhat ameliorated by the presence in Lao PDR of our Lao Programs Director, Chanthasone Phommachanh. Following is a summary of our key stakeholder engagement activities to-date:

## 12. Stakeholder Engagement Program:

Fundamental to Saola conservation is the reality that no single organization or sector of society can do this alone – not NGOs, government, donors, nor local civil society alone can save Saola. All of these stakeholders will be essential to success, and all need to work together, in positive collaboration. Consequently, stakeholder engagement is a fundamental, ever-present part of the Saola Foundation's operational mode and our own 'DNA'.

Primary goals of our Stakeholder Engagement Program are to inform key stakeholders and partners of the importance, priority and urgency of the Saola search program, and to encourage their support to and involvement in the effort. Engagement methods will vary, and are in part dictated, at least for the present, by ongoing Covid-19 pandemic travel restrictions.

### GoL agencies:

Most of our engagement with GoL stakeholders will proceed mainly through in-person meetings – both formal, structured meetings and informal, free-ranging discussions. This is the most effective in the Lao and GoL context, but they will be supplemented, where appropriate and/or required, by the submission of written letters or other documents. Although we are somewhat constrained at this writing by the inability of the Saola Foundation's CEO, President or Technical Director to travel to Lao PDR due to Covid-19 restrictions, our strong National Programs Director, Chanthasone Phommachanh, who lives in Lao, will proceed in the meantime with engagement meetings with GoL.

# Local communities in the Saola's range in Lao PDR:

Although the CEPF-funded components of the Saola search program will focus mainly on technical preparation and engagement with GoL, not on field implementation, these CEPF-funded components will lead directly to and sometimes overlap with the co-funded field phase, which will include engagement with local villagers in the program areas. The Saola Foundation's National Programs Director, Chanthasone, already has strong, positive relationships with many of the villages in the area of the program, and our engagement will build upon that. Over the past 15 years, Chanthasone has built up a strong resumé of experience in positive engagement and collaboration with Lao villagers in remote areas of Lao PDR. This engagement will proceed through in-person meetings, either within the village, or in the course of participatory fieldwork.

# IUCN Saola Working Group:

Since our inception, the Saola Foundation has established strong, positive engagement with the SWG. The results of this can be seen in the reciprocal letters of support each organization wrote for the other's CEPF Letter of Interest in this current funding call. This positive engagement has been fostered and maintained by regular contact (through email and by phone and video conference calls) between the Foundation's CEO (Dr. Lorraine Scotson) and the Chair of the SWG's governance body (Dr. James Burton). This has been further supported by regular contact between other members of the Saola Foundation's Board of Directors and counterparts on the SWG's governance body. In addition, most of the Saola Foundation's staff are members of the SWG.

### Other conservation non-government organizations (NGOs) working in Lao PDR:

Engagement with other conservation partners working in the Saola's range has thus far proceeded and will continue by in-person meetings when possible, and by email contact and video conferencing calls when the only or best option. The most important of these partners currently is the Wildlife Conservation Society Lao Program, with whom all staff of the Saola Foundation have a very good relationship, going back many years.

### **Donors**

Donors are a key stakeholder group in the Saola search program. They will be essential to providing cofunding for program elements not covered by CEPF support, and they will wish to know how their funding has been used, and its impact. The Saola Foundation's donors are spread throughout much of the world, and are comprised mainly of individuals and institutions such as zoos. With Covid-19 travel restrictions, our main means of engaging with donors are one-on-one phone and video conference calls, public online events to which donors are invited, and the Saola Foundation's e-newsletter. Over the span of the CEPF-funded project components, we expect the ability to meet with key donors in-person to gradually increase and return to something approaching normal. The trend is good.

# 13. **Consultation methods:**

## GoL agencies:

As noted above, our engagement with GoL will be mostly through in-person meetings, principally by our Lao Programs Director, Chanthasone Phommachanh and an experienced national consultant who will be engaged specifically for this purpose. This is the most culturally appropriate engagement method. These meetings will be supplemented by the submission, where appropriate and/or required, of written letters or other documents.

# Local communities in the Saola's range in Lao PDR:

Little or no work in local communities is expected under the CEPF-funded components. Subsequent villager engagement during the field phase of the Saola search program will proceed, by necessity and local custom, through in-person meetings, either within the village, or in the field. In the village, meetings most often will be led by the village chief, with GoL central level, district and/or provincial Forestry staff in attendance. Fieldwork components will provide numerous opportunities for less formal consultation with local residents involved in the project.

### **IUCN Saola Working Group:**

Our pattern of regular contact with the SWG will continue throughout the Saola search program, mainly through email and phone and video calls between the Foundation's CEO, Lorraine Scotson, and James Burton of the SWG governance body. In addition, Lorraine and the Saola Foundation's Technical Director Rob Timmins and Lao Programs Director Chanthasone Phommachanh are members of the SWG, providing further opportunities for engagement with the SWG, including its Vietnamese members.

A key phase of consultation with the SWG has already been completed, during our coordination in the preparation of our respective LoIs for this round of CEPF funding. This led to each organization writing letters of support for the other's proposed project.

## Other conservation non-government organizations (NGOs) working in Lao PDR:

Consultations with other conservation partners working in the Saola's range will be by in-person meetings when possible, and by email contact and video conferencing calls when the only or best option.

The IUCN Saola Working Group has also an important role in bringing NGO partners together. The IUCN Lao Programme (host of the SWG's Lao national coordinator) currently plans to host in late April 2021 an in-person and Zoom consultation meeting for all Lao-based conservation partners working in the Saola's range. This will be a good opportunity for the Saola Foundation to consult collectively with these partners regarding our search program and the CEPF-funded components specifically.

### Donors:

Our engagement with financial supporters of the Saola search program, our co-funders, is focused mainly on information-sharing, rather than consultation. That said, we are always available to promptly discuss directly with donors any concerns or questions they may have about the work they support. Most commonly we do this by informal, one-to-one phone or video calls.

14. Other Engagement Activities: This section will describe any other engagement activities that will be undertaken, including participatory processes, joint decision-making, and/or partnerships undertaken with local communities, NGOs, or other project stakeholders. Examples include benefit-sharing programs, community development initiatives, resettlement and development programs, and/or training and microfinance programs.

A key part of the Saola search program and its CEPF-funded components will be working in Lao PDR with GoL, Free the Bears, and other members of Lao civil society to form professional Saola detection teams – skilled in the use of detection dogs, in wildlife tracking, and in rapid field testing of DNA. The formation and training of these teams will provide excellent opportunities to deepen engagement with these stakeholders.

We currently plan to host a technical webinar, led by our technical staff, Rob Timmins and Chanthasone Phommachanh, to explain the why and wherefore of the Saola search program, and answer stakeholder questions. The main target audience will be donors and conservation NGO partners, but the webinar will be accessible to all stakeholders who speak English and have an internet connection. This is planned for mid-2021, possibly before initiation of the CEPF-funded components, but we consider it an important part of the Saola search program, and it will help set the stage for strong, positive stakeholder engagement during the CEPF-funded phase.

## 15. Timetable:

One of the most important stakeholders for the CEPF-funded components of the Saola search program is the Government of Lao PDR (GoL) – particularly of course for the component of development of a Memorandum of Understanding (MoU) to implement the search program. This will require engagement with the central level of GoL – such as the Ministry of Agriculture and Forestry (MAF), Ministry of Foreign Affairs (MoFA) and Department of Forestry (DoF) – and local level, such as Provincial Agriculture and Forestry Offices (PAFO) and District Agriculture and Forestry Offices (DAFO).

Given the crucial importance of this engagement, we describe it in detail in the following table, by the corresponding activity number from our proposal.
