PARTNERSHIP HIGHLIGHTS

CEPF Recruits New Executive Director

Patricia Zurita, formerly senior director of Conservation International's Conservation Stewards Program (CSP), was chosen to head up CEPF as its new executive director. She replaces Jørgen Thomsen, who left the post last year to become director of conservation and sustainable development for the John D. and Catherine T. MacArthur Foundation. Ms. Zurita was selected by a panel of Donor Council representatives. She headed CSP for five years, directing conservation agreement programs in more than 17 countries. Prior to leading CSP, Ms. Zurita worked as the director of economics and policy for the CI Andes Program, a post she took on in 2002. Before joining CI, she worked with the Economics Program of the World Resources Institute developing payment for water services in Panama and Kenya and supporting the development of a phosphorous and nitrogen trading system in the Mississippi Basin and the Chesapeake Bay in the United States. She officially started her new role with CEPF on 1 March 2010.

Fundraising Strategy and Progress Toward Securing Japan's Contribution

Council members reviewed CEPF's current fundraising strategy as part of the Sixteenth Meeting of the Donor Council held on 15 January 2010, and discussed ways to secure Japan's investment and attract new donors. As of December 2009, CEPF had secured \$88 million toward the \$150-million goal for implementation of the current Strategic Framework. Additional funds expected from the World Bank but not yet secured through a formal agreement total \$19 million, which would bring the total secured to date to \$107 million, leaving \$43 million in new funds that must still be raised for full and effective implementation of the Strategic Framework. The World Bank representative told fellow Council members that the Bank's total commitment of \$25 million stands firm.

The Senior Vice President for Government Relations in Conservation International's Center for Conservation and Government (CCG) traveled to Japan in January 2010. He met with Rintaro Tamaki, Vice Minister of Finance, and Toshinori Doi, the Donor Council member and Director General for the Development Policy Division, International Bureau in the Ministry of Finance, to discuss the CEPF partnership. He also met with other representatives in the International Bureau as part of an information session about international conservation issues, including CEPF. Yasushi Hibi, Vice President for Asia Policy and Managing Director for CI Japan, also joined the meetings. The Senior Vice President also met with Masaki Suzuki, Director General, Nature Conservation Bureau, Ministry of the Environment, as well as representatives from JICA and JBIC.

Following up on the meetings that CI's Senior Vice President for Government Relations had, the CEPF Executive Director will meet with Ministry of Finance and Ministry of Environment representatives during a visit to Japan in late March. The objectives of the meetings are to:

- Introduce herself as the new Executive Director, discuss the plans ahead and ensure collaboration with the Government of Japan; and
- Present a preliminary communications plan for Japan for feedback.

The results of these meetings will be shared with the Donor Council at the meeting on 23 April 2010, as will an update on the 2010 communications planning and activities addressed under *Agenda Item #4, Follow Up to Decisions Taken at the Sixteenth Meeting of the Donor Council*.

Evaluation of CEPF Impact and Other Assessments

As described in Document CEPF/DC17/6, the findings from the current evaluation of CEPF impact will be presented to the Donor Council by independent evaluator David Olson. At this time, the consultant will also have presented the results to the Working Group on 9 April 2010. Results of the presentation and discussion will be shared with the Donor Council at the meeting.

Also in March, the Secretariat hosted the independent evaluation team conducting the evaluation of the MacArthur Foundation's Conservation & Sustainable Development Area, Program on Global Security and Sustainability. The session, which included a full day of meetings with CEPF, focused on CEPF impact and lessons, as well as CEPF's interaction with MacArthur.

The assessment that the Center on Applied Biodiversity Science is doing on how CEPF has contributed to the 2010 biodiversity targets is underway.

Progress on New Priorities

Caribbean Islands Biodiversity Hotspot

As part of the Donor Council meeting on 15 January 2010, the Council approved the ecosystem profile for the Caribbean Islands biodiversity hotspot, including its strategy for the fund's new five-year, \$6.5 million investment in the region. The approval followed an extensive process of stakeholder consultations and expert studies coordinated by BirdLife International (Caribbean Program) in collaboration with Durrell Wildlife Conservation Trust / Bath University, and the New York Botanical Garden, with technical support from CI's Center for Applied Biodiversity Science. At least 200 individuals representing more than 160 governmental and nongovernmental institutions have contributed to the development of this ecosystem profile

In addition, the Working Group met on 16 March 2010 to review the Secretariat's analysis and ranking of applications for the regional implementation team for the Caribbean Islands investment. Group members discussed the two applications deemed appropriate for consideration as the regional implementation team, and decided to recommend The Caribbean Natural Resources Institute (CANARI), contingent on CANARI providing adequate additional details on how it will ensure sufficient monitoring of projects and staffing, and how it will guarantee quality financial management. The organization is expected to now further elaborate on these issues for Working Group review through a memo that will be approved by the Working Group on a no-objection basis after one week of being submitted. After this period, the Working Group will make a formal recommendation for approval to the Donor Council.

As reported on as part of the *Agenda Item #4, Follow Up to Decisions Taken at the Sixteenth Meeting of the Donor Council*, the Council directed the Secretariat to rapidly develop a proposal for its consideration regarding what CEPF could do to help in earthquake-ravaged Haiti, with a particular focus on natural resource conservation. The Secretariat submitted to the Donor Council a comprehensive proposal for \$400,000 in emergency assistance for Haiti, which was approved through a no-objection process as of 10 March 2010. These funds, which are in addition to the approved \$6.5 million investment for the Caribbean Islands, will support efforts to:

- Assist in the immediate recovery of civil society groups that focus on environment and development.
- Foster stakeholder engagement and integration of environmental concerns into reconstruction and development planning.

- Prevent the degradation and potential destruction of two of Haiti's most important areas for biodiversity, Massif de la Hotte and Massif de la Selle.

BirdLife International's Caribbean Program will administer the emergency funds, which come from a recently cancelled \$377,878 grant in the Atlantic Forest Hotspot and a small amount of funding (\$22,122) remaining from other regions that have also completed their original investment phase.

Maputaland-Pondoland-Albany Biodiversity Hotspot

The ecosystem profile for Maputaland-Pondoland-Albany was sent to the Donor Council for no-objection approval on 26 February 2010 for the 45-day review period. The deadline is 12 April 2010. The Regional Implementation Team selection process began with a call for proposals on 1 March 2010. For the first time, the Secretariat offered a discussion for interested parties via a teleconference on 15 March 2010. The conference call was attended by four organizations and was recorded, so all the answers can be made available to other potential partners through CEPF's Web site. This process is being tested as an additional way to provide equitable information to all potential applicants interested in becoming a Regional Implementation Team and to assist them producing good quality proposals. The deadline for proposals is 5 April 2010.

Mediterranean Basin Biodiversity Hotspot

A full draft of the Mediterranean Basin ecosystem profile has been distributed to stakeholders and a final, regional stakeholders' meeting is scheduled for 30 March 2010. The Executive Director and Grant Director John Watkin will attend the meeting. In related developments, the Secretariat finalized a \$132,000 agreement with the MAVA Foundation to join the CEPF partners in supporting the ecosystem profile. The Swiss foundation aims to promote the protection of nature with particular focus on preserving rare or threatened species and their habitats; preserving biodiversity and landscapes; and sustainable management of natural resources. MAVA Foundation is reviewing its investment strategy for the Mediterranean and is using the information of the draft ecosystem profile and the results of the final regional stakeholders' meeting as key input to finalizing its investment strategy in early April. An agreement is also expected to be signed soon with the Prince Albert II of Monaco Foundation in support of the profiling activities. The Executive Director will be meeting with both MAVA and Prince Albert II of Monaco foundations in Tour du Valat on 29 March 2010 and will report back on the results of these conversations during the 23 April 2010 meeting.

FEATURED NEW GRANT

CEPF awarded 34 new grants during the period, bringing the global portfolio to \$121.1 million. A full list of grants approved since the last meeting of the Donor Council is included with this report.

These grants include, for example, support to Fundación para el Desarrollo de Alternativas Comunitarias de Conservación del Trópico (ALTROPICO) in its conservation and sustainable development work in northwest Ecuador as part of the \$1.95 million consolidation program for the Tumbes-Chocó-Manabí biodiversity hotspot. The grant is part of the consolidation strategy to get governance and management structures and plans adopted and implemented in the bi-national region.

The target sites include areas in the buffer zone of the Cotacachi Cayapas National Park, and are highly strategic for maintaining altitudinal connectivity, ever more important in light of fragmentation and climate change. The areas have been under threat from forest conversion due

to logging, oil palm cultivation and mining. Socio Bosque, a government program that gives annual monetary incentives directly to individual landowners or indigenous communities who voluntarily decide to protect their native forest, is proving to be an important financial incentive to maintain lands under forest. The new funding — \$250,000 — will be used to promote mechanisms for institutional, financial and social sustainability in the binational conservation corridor between Ecuador and Colombia; and assist Chachi indigenous communities to maintain access to Socio Bosque by updating communal land tenure and strengthening local capacity for land management. It also will work with 150 land owners in Golondrinas Protected Forest, to complete all requirements necessary to access Socio Bosque funding. In addition, the grant supports development and implementation of a binational conservation and sustainable development agenda.

FROM THE FIELD

Southern Mesoamerica

During a recent ceremony in Bluefields, Nicaragua, nearly 407,000 hectares were titled to six indigenous and three Creole groups. The beneficiary communities included Rama Cay, Sumu Kaat, Tiktik Kaanu, Wiring Cay, Monkey Point, Bang Ku kut, Caño Maíz, Río Indio, Grey Town and 23 cays. Building the capacity of the Rama indigenous group to conserve its own lands, which include rainforest and coastal wetlands along Nicaragua's Atlantic coast, is one of the goals of CEPF's investment in the Southern Mesoamerica region. CEPF first entered this impoverished region in 2002. The indigenous governing council lacked the infrastructure and equipment to manage the large territory, and the land was under threat regularly from forest fires and agricultural encroachment. During its initial investment in the Indio Maiz region, CEPF supported a highly participatory, stakeholder-driven process to develop a management plan that is considered a model for Nicaragua. Activities also included baseline studies for the demarcation of Rama indigenous territories. Consolidation funding for the region starting in 2008 focused in part on strengthening local governance structures and management capacity in critical areas primarily indigenous reserves along the Caribbean. Consolidation funds went to Conservation International's Costa Rica office to support work with local partners to help the Rama build their capacity to manage the land, and to provide the technical studies required for the Rama to get government-recognized control over their lands, including a detailed and time consuming census of the large territory.

A CEPF small grant to Panamanian community group Association of Friends and Neighbors of the Coast and Nature (AAMVECONA) helped the organization develop its conservation program at the San San Pond Sak wetland. The organization's work was recently rewarded via announcement of an expanded partnership with Chiquita Banana, the German Technical Corporation Agency GTZ, the Costa Rican banana industry body CORBANA and German retailer REWE. It will result in part in 500,000 Euros to improve management of the wetland, an extensive manatee habitat along the Caribbean coast of Panama near Costa Rica. The expanded three-year public-private partnership focuses on biodiversity, environmental education, community development, new income sources for residents (with a focus on women and indigenous communities) and developing international cooperation.

Indo-Burma

The government of Cambodia recently announced greater protection for six of the largest remaining tracts of lowland grassland in Southeast Asia – a total of 31,159 hectares. Several globally threatened species are found in the new protected areas, located in and around the Tonle Sap floodplain. Local communities rely on the grasslands, which flood seasonally, for fishing, grazing and deep-water rice farming. One of the sites is located in Siem Reap province and the

other five are in Kampong Thom province. Previously under a provincial conservation order, the sites' new status empowers Cambodia's Ministry of Agriculture, Forestry and Fisheries to take action to prevent activities such as land-clearing and dam-building. The new designation of these areas is the result of efforts by CEPF grantee Wildlife Conservation Society, which worked with Cambodia's Forestry and Fisheries Administrations, along with local governments and community stakeholders. Also involved in the effort were Centre d'Etude et de Développement Agricole Cambodgien (CEDAC), the Sam Veasna Center, BirdLife International in Indochina, the Angkor Center for Conservation of Biodiversity, and the University of East Anglia. Among the species that will benefit from the enhanced protection of these sites is the endangered Bengal florican, whose global population likely numbers less than 1,300.

Securing Safe Environment for Critically Endangered Vulture Species by Declaring and Ensuring Diclofenac-Free Zones in Central and Western Low Lands of Nepal

Secure safe environment for Critically Endangered vulture species in the Terai Arc Landscape of Nepal through sensitization of stakeholders, developing appropriate policy and regulation, and declaration of diclofenac-free zones. The project will also build the capacity of stakeholders in monitoring and management of vultures and their habitats for long-term conservation.

Strategic Direction 1. Safeguard priority globally threatened species in Indochina by mitigating major threats

Building a Partnership for Establishing Sustainable Management at Key Wetlands for Sarus Crane in the Cambodian Lower Mekong

Develop partnership and joint-planning among the Wildfowl & Wetlands Trust, Mlup Baitong, and Chamroien Chiet Khmer, resulting in submission to CEPF of complementary project plans to establish long-term sustainable management of Boeung Prek Lapouv and Kampong Trach, two key sites representative of the lower Mekong floodplain wetlands with priority non-breeding populations of sarus cranes.

Cat Ba Langur Conservation Project

Bolster conservation efforts for Cat Ba Langur, one of the world's rarest species of primates, by ensuring strict protection of the remaining population, reducing habitat fragmentation and destruction of natural forest in the buffer zones of Cat Ba National Park and Biosphere Reserve, strengthening the capacity of governmental forest protection agencies and reducing population fragmentation through intensive management.

Feeding and Breeding Ecology and the Conservation of the Vultures in Cambodia

Food Provision to Cambodia's Vultures

Identifying Priority Populations and Reviewing Current Known Distributions for Threatened Bat and Turtle Species in Northern and Central Vietnam

Fill critical gaps in knowledge on five globally threatened animal species (Indochinese box turtle, four-eyed turtle, impressed tortoise, wattle-necked softshell and Vietnamese leaf-nosed bat) for which core populations have yet to be located in Vietnam by undertaking targeted field surveys, formulating specific management recommendations for protected area managers, and conducting targeted awareness raising for local communities.

Identifying Wet-season Sites and Non-breeding Habitats Used by the Critically Endangered Bengal Florican in Cambodia

Recommend appropriate wet-season habitat management and site-based conservation management of the Critically Endangered Bengal florican in the Tonle Sap floodplain, Kampong Thom Province, Cambodia by field research — including satellite tracking — to locate key wet-season sites, identify non-breeding habitat preferences and assess threats to non-breeding sites.

Launching the Flagship: Collaborative Saola Conservation

Northern Plains of Cambodia Kouprey Survey

Raising Awareness and Building Capacity to Manage Human-Elephant Conflict in Mondulkiri Province, Cambodia

Improve the attitudes of people in northeast Cambodia towards elephants by raising awareness of elephant conservation and human-elephant conflict among local communities, ethnic groups, agrobusiness and local government, and to enable local people to manage human-elephant

conflict by providing a range of conflict mitigation strategies including deterrents ranging from chili ropes to watchtowers to fireworks.

Consolidate a 150,000-hectare conservation corridor sited in between Munchique and Tatama national parks through 25 private reserves. The grant promotes financial sustainability of the corridor by promoting ecotourism and environmental agricultural products. Activities also include increasing the capacity of private reserve owners to pursue the connectivity strategy and a communication strategy to document and disseminate the results and lessons learned.
