## **Annex – Technical progress report**

### **Progress Report to the Critical Ecosystem Partnership Fund**

**Dr Neil Burgess**

**May 10<sup>th</sup> 2009**

#### **Background**

CEPF investment to East Africa has been operational since early 2004. Throughout 2004 and until the end of 2006 UNDP-GEF supported the salary of Dr Neil Burgess to provide a technical input to the review of the more than 200 LOIs that were submitted to the CEPF coordination unit, and supported his technical input to the majority of the CEPF projects operational in Tanzania. The UNDP contract for Neil Burgess finished on the 11<sup>th</sup> January 2007.

After returning to the UK Neil Burgess was contracted by CEPF through WWF UK to provide a limited number of services to the Coordination Unit and the CEPF programme in the East African region. In this short report I outline what has been done against the major deliverables of that contract by the end of the reporting period in 2009.

#### **Reporting against deliverables**

- 1) *Input to the consultancy report from the sustainable finance team that fully reflects the existing structures in the region and the possibilities to sustainably finance conservation in the longer term.* I met with the consultants and provided considerable input to their work through providing reports and financial materials, linking them to relevant people in the region, and by providing comments on the draft report. I have also promoted the final report within WWF and other organizations, and used it as the basis of a PhD programme for a student at Cambridge University. Finally, I helped WWF EARPO to develop the LOI, and Terms of Reference for fundraiser to take advantage of the remaining funding within SD5.
- 2) *Relevant inputs to the sustainable biodiversity monitoring project coordinated by BirdLife International to see the finalisation of the expected products.* I provided a series of detailed comments on the draft report produced by the BirdLife team. I have also been sending papers, GIS datasets, and any other relevant materials upon request to the BirdLife team undertaking this work. I have also provided significant input to the CABS-led work on the assessment of forest change in the Eastern Arc Mountains and Coastal Forests, including the GIS data that forms the basis of the outcomes monitoring database for KBAs.
- 3) *Links provided between the various projects working on ecosystem services.* I have continued to play a role in coordinating and linking projects working on ecosystem services in this hotspot, particularly in Tanzania.

- 4) *Comments on the various LOIs received by CEPF for the small grants programme.* I have provided comments on all the LOIs I have been sent by the BirdLife team coordinating this work.
- 5) *Various reports from the projects already funded by CEPF, especially those being managed by Frontier-Tanzania, TFCG, Trento Museum, etc.* I have read and provided comments on the reports for Mahenge and Nguru Mountains produced by Frontier-Tanzania and for the North Pare Mountains and Mufindi part of the Udzungwa Mountains by TFCG. I have also worked with Giulia Wegner and collaborators to see the paper on the biological values of the forests in Mtwara ready for publication by JEANHS. Finally, I have worked with Jackie Hall to complete and submit a paper to Biological Conservation on trends in deforestation in the Eastern Arc Mountains from 1955-2000.
- 6) *Assist the CU to organise a final review meeting / conference of the CEPF programme in the region (in 2008).* I participated in the final review / mission for the CEPF programme in Dar es Salaam, and made comments on the final report that was produced. Since then I have been discussing input to the consolidation funding proposal that will be prepared by CEPF.

### **Financial matters**

Funds for the grant were provided from CEPF to WWF UK. All the funds have been used and accounted for.
