#### **IMPLEMENTATION PARTNERS**

- Association of former women sea turtle traders "Quero Ter um Futuro com Destino" Programa Tatô has been working closely with this community-based productive group composed exclusively of former sea turtle women traders since 2016. During this project, this association has benefited from training, resources and technical support to diversify their productsfor the local market. These women were involved in the preparation and facilitation of the dialogue spaces between women from the 6 target communities.

Fundação Príncipe participated in the training workshop focusing on the production of reusable menstrual pads organized in Sao Tome for the women productive groups in order to reduce the costs of the project developed by Fundação Príncipe and to promote the experience exchange between the organizations of São Tomé Island involved in the project. Also, a trip was organized for exchange of knowledge and experience, where 3 members of the women productive group of Sao Tomé went to Príncipe Island to value lessons learned on the capacity building of community groups of women involved in handicraft production and reusable products as an economic alternative of activities harmful to biodiversity. Together with Fundação Principe it was also promoted the first national meeting of the Network of Civil Society Women organizations of São Tomé and Príncipe (Rede das Mulheres da Sociedade Civil de São Tomé e Príncipe) a national women's movement for the sustainable development of São Tomé and Príncipe, to create a network of exchange, mutual assistance and learning.

#### **Unexpected impacts (positive or negative)?**

One negative unexpected impact, was the fact that we produced less menstrual pads than predicted in the project proposal. Although we expected to produce 1300 menstrual pads, due to several challenges and difficulties encountered and described below, only 314 reusable menstrual pads were produced during the project duration. Nevertheless, we will continue to produce these menstrual pads and sell them on the local market. A positive unexpected impact was the invitation of the NGO Helpo and the Institute of Drugs and Drug addiction of Sao Tome, to Programa Tatô and the productive group of women to lead and facilitate two dialogue sessions on biodiversity conservation, reduction of pollution, health and menstrual education, in two coastal communities in the southern coast of São Tomé Island (Angra toldo and Ribeira Peixe) where 44 women and 37 men were present. At the end of the sessions, reusable menstrual pads produced by the association "Quero Ter Um Futuro Com Destino" were distributed for each woman participating in the meeting, purchased by the NGO Helpo.

### PROJECT RESULTS/DELIVERABLES

#### **Overall results of the project:**

This project was very positive, interesting and useful, with an integrated approach, contributing not only to raise environmental awareness, promote biodiversity conservation, environmental protection and reduction of pollution, but also contributing to gender equality, the improvement of livelihoods and the quality of life of several members of local coastal communities, capacity building of civil society organizations led by women and partnerships between them.

This project was an important opportunity to diversify the activities of the group of former sea turtle women traders, helping them to be less dependent on the tourism sector to sell their handicrafts production (in the context of Covid19), making them more resilient and thus more committed to mitigating threats to sea turtles, thus contributing to the conservation of marine biodiversity and the reduction of marine pollution, thanks to the promotion to the use of reusable products.

The project took advantage of important opportunities and valued ongoing initiatives through the exchange of experiences and training mutual efforts by Associação Missão Dimix and Associação Mamã Catxina. These partnerships were very positive and allowed the women's productive group to increase their capacities both at the production level of a new product, as well as at the organizational, leadership and communication levels. 314 reusable menstrual pads were produced, 217 of which were freely distributed and are being used by

vulnerable women from the 6 target coastal communities and 97 were sold on the local market.

The partnership with Fundação Príncipe was very positive and allowed to promote the exchange of experiences and maximize the impact of our actions at the national level; thus strengthening the collaborations between the sea turtle conservation programs of the two islands of Sao Tome and Principe.

Several informative and awareness-raising tools and materials were designed and developed about environmental preservation and women's empowerment such as posters (50 posters), flyers (2500 units), t-shirts (200 units) and awareness-raising spots broadcasted on the national media (4); see the photographs and links of these awareness-raising media attached to the report. Surveys of women and young women in target communities (Morro Peixe, Fernão Dias, Micoló, Gamboa, Loxinga and Cruz) were carried out among women who participated in dialogue groups about their perceptions of threats to marine biodiversity, problems related to marine pollution and menstrual habits, in order to understand the dimension of the use of disposable products and the impacts associated with waste production on the island. The results demonstrated not only an opportunity in the production of other reusable products, but also demonstrated that there is a lot of work that needs to be done in terms of raising awareness on the indiscriminate waste disposal linked to intimate hygiene and other household activities in nature to minimize impacts on public health, environment and biodiversity.

The group of 17 former sea turtle women traders engaged in a process of professional reconversion since 2016 showed great interest and enthusiasm for the project and actively participated in both of the design of reusable pads, as well as raising awareness among coastal communities about the importance of reducing marine and terrestrial pollution and using adapted solutions to the women's needs like reusable menstrual pads. This contributed to strengthen the professional reconversion process and therefore mitigate impacts on sea turtle population. There was also a good level of participation and interest of women living in the 6 target coastal communities, in all the sessions of dialogue spaces between women, organized by the project This contributed to the adoption of more environmentally friendly practices for preserving the coastal and marine environment, improving women's menstrual health and empowering these women.

#### **LESSONS LEARNED**

a. To ensure that the dialogue sessions in the target communities had success, we did a participatory pre-assessment of the participants' expectations and the topics they would like to address before each dialogue session. The fact that each dialogue session was prepared in advance, selected and adequate environment for holding the meetings to ensure a good women group atmosphere, and the use of interactive games and facilitation techniques to build trust and confidence among the participants, was extremely positive.

b. Midway through the project period we realized that the productive group of women had to be divided into tasks for an effective production of the reusable pads. So, a better organization of tasks and a longer period of adaptation were needed, since the sewing of the pads requires practice and experience, in order to guarantee their quality. After an analysis and assessment of each woman's abilities, the work was divided in specific tasks for each woman according to their individual skills and capacities in order to increase the production.

### SUSTAINABILITY/REPLICATION

With this project implementation, Programa Tatô, together with its partner organizations (Fundação Príncipe, Missão Dimix and Mamã Catxina), trained, built capacity, shared experiences and diversified the activities of the women part of the productive group of former sea turtle traders "Quero ter um futuro com destino" (I want a future with destine). The development of this new product, like the reusable menstrual pads, as well as the as well as the previous handicraft products already in production before the project start, will continue to be developed, benefiting from the partnerships developed during the project period, as well as their follow-up and supervision, so that this activity continues its effectiveness in the long term.

We expect to continue to develop new partnerships to support their business and to raise awareness among more people, like the partnership that was recently developed with the NGO Helpo and the Institute of Drugs and Drug addiction by the end of the project, where dialogue sessions on biodiversity conservation, reduction of pollution, health and menstrual education, were organized for 81 people (women and men) and distributed reusable menstrual pads made by the productive group and purchased by the NGO Helpo. By investing in the diversification of handicraft products made by the women productive group and in products that can supply the local market, it allows us to respond to the needs of São Tomé society and consequently to achieve economic profitability more quickly and, therefore, the economic sustainability of these group of women.

In addition to the local sale, we are valuing the selling spots of both Programa Tatô and the productive group of women available to a target audience with greater financial capabilities and, therefore, can be sold at more competitive prices to improve the performance of this productive group.

Programa Tatô has been accompanying, supporting and ensuring continuous training for this group of women since 2016 and is committed to continuing to monitor the development and growth of their activities so that they can gain autonomy and guarantee the sustainability of their professional reconversion in the long term.

The integration of the productive group of women "Quero ter um futuro com destino" in the National Network of Women for Sustainable Development of São Tomé will also guarantee the support, exchange, mutual assistance and learning from a network of women at national level.
