Two capacity building and strategic planning workshops were held on Tanna. The workshops aimed to provide local community organizations with the technical skills that they require to work closely with the communities and stakeholders on Tanna to undertake conservation actions on Tanna.

An outcome of the first workshop was that a draft capacity building manual for CSOs was produced for community based organisations, and input was gathered for the VEAN strategic plan.

A second workshop was held on the Western side of the island, and the strategic Plan for VEAN was circulated for approval.

Community members from the Mt Tukusmera where the collared petrel are nesting attended the workshops.

The strategic plan developed will cover medium and short term strategy and can be used after the end of the project period. The document is subject to a review when is need arises. Other conservation NGOS will have access to the strategic plan and lesson learned will be shared with other organization. VEAN provided support to a number of CSOs who apply for funding to the GEF small grants program. This has been the primary form of funding for VEAN prior to the current CEPF program. VEAN charges a nominal annual subscription to each of the CSOs, and in return provides technical skills, knowledge, access to the internet, and office facilities.

# 4. Describe the success or challenges of the project toward achieving its short-term and longterm impacts

VEAN has been the recipient of CEPF funding through the BirdLife International led project: "Investing for the Environment – Building Civil Society Capacity to Drive Conservation Success in Vanuatu Code No. 64259". This has helped to establish VEAN and give VEAN the confidence to carry out financial management, project management and biodiversity conservation measures for ourselves and our members. VEAN is an 'umbrella' organization for locally-based CSOs across the country – we have 32 CSO members, 4 of whom are closely associated with Priority KBAs in the country. The VEAN Board have recommended that we provide support to the members in a number of areas – including financial management and organizational governance. We would plan to organize workshops for CSOs to further benefit from these important capacity needs.

One unexpected outcome is that the landowners of the land around Mt Tukuasmera where the Collared Petrel are nesting are so concerned about the declining population of the bird that they formed a new conservation committee called Tekerkak Conservation Committee.

We improved our relationship with the Tannabased CSOs, such as Taule Taule, improving their capacity to facilitate conservation actions. We hope to be able to replicate this training and outreach in other parts of TAFEA province and throughout Vanuatu With a greater understanding of what is required, they themselves can be confident in continuing the work after the project finishes, seeking alternatives to help sustain the conservation initiatives into the future.
