Implementation Partners for this Project (please explain the level of involvement for each

During this project implementation, Rwanda Development Board (RDB) was the key partner in the whole process of developing the Gishwati-Mukura Guidebook. RDB is in the process of taking over the management of the Gishwati-Mukura National Park and start tourism. The consultant was guided by the RDB team to ensure that their perspectives are considered, and the workshop to discuss the final draft of the guidebook was invited by RDB. Different partners including: Rwanda Environment Management Authority, RUTSIRO District, Wildlife Conservation Society (WCS), International Gorilla Conservation Programme (IGCP), ARCOS and different Tour Operators have also been involved in the discussion of the guidebook and provided important inputs. Also, three local community groups: KOVAKARU (a women handcrafts cooperative), KOAGIRU (a cooperative of traditional healers) and INDASHYIKIRWA (an indigenous historically marginalized group that perform traditional dances to tourists); were involved in this project. 15 representatives of these Community groups including: 9 women and 6 men were trained in community based tourism products improvement and 20 women grouped in KOVAKARU were trained and equipped with different materials to improve their handcraft products.

## **Conservation Impacts**

Please explain/describe how your project has contributed to the implementation of the CEPF ecosystem profile.

This project supported local economy development, building the capacity of local people through training and equipment provision. This helped three community groups supported to improve and diversify existing tourism products and thus increase the income. It also generated positive changes in local people behavior and increased the local support to ensure the long term protection of the Gishwati forest. This project also helped to produce a guide book about the Gishwati-Mukura National Park species richness and other ecosystem services that it provides. This will continue enhancing the understanding of Gishwati- Mukura National Park Ecosystem

and increase conservation support. All these interventions significantly contributed to the CEPF strategic direction 1: "Mainstream biodiversity into wider development policies, plans and projects to deliver the co- benefits of biodiversity conservation, improved local livelihoods and economic development" specifically its investment priorities: (a) Communication materials that show the beauty of the Eastern Afromontane hotspot / Eastern Afromontane KBAs. (E-)Books, photos, films, videos, and/or other PR materials that can be used to raise interest/awareness about the hotspot and its many values (ecological, cultural, aesthetical, economic etc...) and (b) Materials that show the value of *specific KBAs*, and the impact of CEPF investment at these KBAs.

# Please summarize the overall results/impact of your project against the expected results detailed in the approved proposal.

This project had been successful and we are confident that it made a significant contribution to raise the understanding of Gishwati Mukura national park. The species richness and the value of the Gishwati Natural Forest are widely communicated through the produced guidebook in collaboration with Rwanda Development Board. Through training provided, the knowledge of three community groups about customer care for tourists is increased, their tourism products and marketing skills are improved. This have had a positive impact on the incomes they are generating from community based tourism. Also, women grouped in KOVAKARU Cooperative are nowadays making shining and attractive handcrafts products as a results of this project. The value of their products is expected to rate more than twice due to this project contribution having an impact on both local economy and the Gishwati Mukura national park conservation.

This project was not directly supporting the protection of a KBA but it was making a contribution to increase the local support to ensure the long term protection of the Gishwati KBA (The northern part of Gishwati Mukura national park) of 1,484 ha and its biodiversity that includes eastern chimpanzees (threatened on the IUCN red list), golden monkeys (endangered) and L'hoesti monkeys (vulnerable).

# Describe the success or challenges of the project toward achieving its short-term and long-term impact objectives.

As mentioned above the project have been successful. We had two targets: Producing the Gishwati-Mukura Guidebook and improving existing community tourism products. We are confident that we produced suitable guidebook as we gained the support from RDB. We also expect it to be useful for many people and widely communicate the beauty of Gishwati Mukura National Park. We highly involved our stakeholders in the planning and gained their support in this project. The community group supported got the professional training that significantly contributed to the improvement of existing community tourism products especially handcraft products.

Even if there have been a delay in producing the guidebook but it has not affected the real impact that was needed. This was mainly due to the change made on the initial plan. Before, we planned to work only on the Gishwati forest, but through discussion we have been asked to produce a guidebook on the two parts of the Gishwati-Mukura national park.

### Were there any unexpected impacts (positive or negative)?

As a results of this project, three community groups supported, decided to create a union that will help in marketing the community tourism products and advocacy. This will be a strong voice for these community groups and will not only positively affect local community development but also the conservation of the Gishwati Mukura National Park.

As a results of this project achievements, FHA received a small grant of \$800 from the Gishwati foundation on behalf of one of the Gishwati community groups, KOAGIRU (a cooperative of traditional healers). This funding will help KOAGIRU to get a nearby medicinal plant demonstration garden so that visitors can see which plants are used in traditional medicines. This garden will also serve as sustainable source of their medicines.

# Sustainability/Replicability

We are confident that the developed Guidebook is going to be used and will be updated in case needed. This is because we gained the support of the RDB conservation and tourism team during the development of the guidebook. This project also helped FHA to continue linking conservation and local livelihoods, helping to preserve Gishwati biodiversity whilst simultaneously reducing poverty in the area. Even if we have not received other related funds during the implementation of this project, we have a plan to build on the achievements of this project and continue supporting local community development and influence change in attitude towards the conservation of Gishwati-Mukura National park.

As a result of this project we have been able to collect a small donation that will help traditional healers to buy a small land for a nearby demonstration garden to be used as a sustainable source of materials for their medicines and medicinal plant demonstrations. This will continue improving their tourism products.
