1. What was the initial objective of this project?

*The main purpose of this trip was to scope out the major project components involved in creating a habitat change assessment for the Eastern Arc Mountains and Coastal Forests of Kenya and Tanzania, which would contribute to a CEPF project proposed by Birdlife International to assess the status and monitor changes to species and habitats in East Africa. Tasks included: 1) assessing the compatibility between the standardized products produced by the Regional Analysis Program at Conservation International (CI) and that of a UNDP-funded project for mapping forest change in the Eastern Arc Mountains in Tanzania, currently being implemented by the Sokoine University of Agriculture; 2) identifying potential partner(s) that have adequate technical capacity and willingness to assist with the mapping of habitat change in the coastal forests of Kenya and Tanzania; 3) discussing the ground-truthing data acquisition strategy with David Moyer, who is planning to conduct an aerial survey in mid-2005; 4) meeting government and non-government institutions in the region to discuss ways to make the region-wide habitat change assessment most relevant to their work; and 5) working with Birdlife International to refine the overall project work-plan and budget.*

*Until events prove that the strategy is unfeasible within the confines of the Birdlife budget and timeframe, the assumption of this project is that the Coastal Forest Change Analysis will be conducted by host-country institutions with technical training and backstopping from the Regional Analysis department in CI-DC.*

2. Did the objectives of your project change during implementation? If so, please explain why and how.

3. How was your project successful in achieving the expected objectives?

*We have identified the key technical counterpart to assist in the production of the forest change assessment for the Coastal Forests of Kenya and Tanzania; we confirmed that the forest change assessment being produced under the UNDP-funded project by Sokoine University appears to be compatible with the products produced by Regional Analysis (and we will be conducting training to further ensure that this is the case); we briefly discussed coordination of the aerial surveys with David Moyer; we met with an array of institutions to discuss their interest and use of project's results, including WWF-Eastern Africa, NatureKenya, Kenya Wildlife Service, Kenya Department of Resource Surveys and Remote Sensing, Kenya's Museum of Natural History, Regional Centre for Mapping for Sustainable Development, International Livestock Research Institute, International Centre for Agricultural Research, Tanzania Coastal Forest Management Project, Sokoine University of Agriculture, and the University of Dar es Salaam.*
