



Call for Letters of Inquiry CEPF Regional Grantee Exchange for the East Melanesian Islands Hotspot

This call is open from 26th March to 13th April 2018

1. Introduction

The Critical Ecosystem Partnership Fund (CEPF) is designed to safeguard Earth's biologically richest and most threatened regions, known as biodiversity hotspots. CEPF is a joint initiative of l'Agence Française de Développement, Conservation International, the European Union, the Global Environment Facility, the Government of Japan, the John D. and Catherine T. MacArthur Foundation, and the World Bank. A fundamental goal is to ensure civil society plays a critical role in achieving biodiversity conservation outcomes.

2. Background

CEPF's niche for investment in the East Melanesian Islands (EMI) was formulated through a participatory process that engaged civil society, donor and governmental stakeholders throughout the region. The results of this process and the eight-year (2013-2021) strategy that CEPF has identified for supporting biodiversity conservation in the region are outlined in the EMI ecosystem profile. Five strategic directions were identified, covering 20 Key Biodiversity Areas (KBAs) in the three countries that are eligible for CEPF support, and addressing threats to 48 priority species. The CEPF investment strategy supports biodiversity conservation in ways that deliver significant, meaningful benefits to local communities, while making a sustained contribution to the development of local, national and regional capacity for conservation.

Strategic Direction 4 of the CEPF investment strategy aims to "Increase local, national and regional capacity to conserve biodiversity through catalyzing civil society partnerships." It seeks to local build capacity to ensure the effective delivery of Strategic Directions 1, 2 and 3. Part of this strategic direction entails facilitating networking, to build strong and active partnerships that will lead to exchange of skills and knowledge, and to build synergies among CEPF partners. In addition, facilitating learning and sharing of lessons and experiences is part of CEPF's global mandate.

3. Scope of Call

This call is a request for Letters of Inquiry (LOIs) from suitable organizations to organize a CEPF Regional Grantee Exchange and to compile a conference proceedings report which includes the key lessons learned from all active or completed CEPF funded projects in the EMI hotspot to date.

The successful applicant will work closely with the IUCN Oceania Regional Implementation Team (RIT) and the CEPF Secretariat to plan all details of the conference including the participants list, resource people, agenda and production of the conference proceedings report.

4. Goals of the Regional Exchange

The regional exchange will provide an opportunity for CEPF grantees, donors, and governmental partners to meet to share their experiences and lessons learned in the course of implementing their CEPF grants and conservation projects more broadly in the EMI hotspot. The workshop will feed into the CEPF mid-term assessment, and support evaluation of progress toward achievement of the conservation outcomes contained in the EMI ecosystem profile.

The main goals of the regional exchange are as follows:

- for grantees to share experiences and lessons learned with other grantees and partners;
- to provide a training opportunity for grantees in relevant areas of interest;
- to give CEPF donors and government partners an opportunity to meet with grantees in the East Melanesian Islands hotspot and learn first-hand the achievements that CEPF support has provided to grantees;
- to conduct outreach to EMI media outlets to disseminate information about CEPF's grantees and their achievements in biodiversity conservation and sustainable development;
- to assess CEPF progress in achieving the conservation outcomes of the ecosystem profile, identify and
 evaluate the key gaps, and set the priority thematic and geographical focal areas for the remaining
 years of the investment; and
- to give grantees an opportunity to provide feedback to CEPF on the grant management process.

CEPF envisions the regional exchange to be a three-day meeting, tentatively planned for 11 to 13 July 2018 at a suitable venue in Honiara, Solomon Islands. Annex 1 lists all active and completed CEPF projects in the EMI hotspot.

5. Who can apply for a CEPF grant?

Non-governmental organizations, private enterprises, universities and other civil society applicants may apply for funding. Organizations must have their own bank account and be authorized under relevant national laws to receive charitable contributions. Government owned enterprises or institutions are eligible only if they can demonstrate that the enterprise or institution can fulfil the following criteria:

- i. is a legal personality independent of any government agency or actor;
- ii. the authority to apply for and receive private funds; and
- iii. may not assert a claim of sovereign immunity.

Further, individuals are encouraged to work with civil society organizations to develop an application rather than apply directly. Anyone who is uncertain of their eligibility or likelihood of receiving funds from CEPF should contact the RIT at helen.pippard@iucn.org.

6. Terms of Reference

Letters of Inquiry (LOIs) from suitable organizations are being sought to complete the following main activities:

- i. Organising and paying for the three-day conference in the amount for approximately U\$\$55,000.00. This budget should include the following:
 - Booking and paying for logistics related to travel, including international and domestic travel, airport transfers, accommodation in Honiara and en route to Honiara as necessary, and paying per diems for non-workshop related meals and incidentals, for

approximately 55 participants, from the Solomon Islands, Papua New Guinea, Vanuatu, and Australia. Participants covered in this proposal will originate from four countries:

- b. Booking and paying for the conference venue in Honiara.
- c. Organising and paying for workshop refreshments (morning and afternoon teas and lunches) for three days for as many as 70 people.
- d. Organizing and paying for one evening cocktail event.
- e. Necessary staff time for conducting these activities and related costs related to grantee staff attending the meeting
- ii. In consultation with the IUCN Oceania RIT and CEPF Secretariat, prepare and disseminate the conference invitation and conference materials to CEPF grantees, donor organizations, and government representatives.
- iii. Prepare and finalize the meeting agenda in consultation with the RIT and CEPF Secretariat.
- iv. In consultation with the RIT and CEPF Secretariat, contract a suitable conference facilitator.
- v. Develop and implement a media outreach plan to disseminate information about CEPF's grantees and their achievements, before, during and following the exchange.
- vi. Provide the necessary assistance in recording and audio-visual equipment.
- vii. Write up the proceedings and a summary of the conference.
- viii. Maintain regular communications with the IUCN Oceania RIT and CEPF Secretariat.
- ix. Timely submission of financial and progress reports.

7. Timeframe

The anticipated start date for this project is 1 May 2018. The anticipated end date for this project is 30 September 2018. The Regional Exchange is expected to be held during from 11 - 13 July 2018.

8. How to apply

The deadline for submission of the LOI is 6:00 p.m., 13 April 2018 (Eastern Standard Time for Washington, D.C.)

- i. Applicants must submit a letter of inquiry through the Conservation Grants electronic portal. CEPF will not accept letters of inquiry via electronic mail or any other mechanism. Interested applicants should complete the Letter of Inquiry (LOI) which should fully address the terms of reference with particular emphasis on:
 - a. A draft budget
 - b. Summary of the experience of the organization in organising conferences of this nature
 - c. Available staffing
 - d. Timeline
 - e. Any partners that you will be working with on this project.

Applicants who do not have a Conservation Grants account will be required to <u>register a new account</u>. Questions regarding account creation or the application process should be emailed to conservationgrants@conservation.org.

- ii. Complete the LOI in ConservationGrants no later than the deadline of 6:00 p.m., 13 April 2018 (Eastern Standard Time for Washington, D.C.). You will receive an email acknowledging receipt of your application. Please note that hardcopy LOIs are not acceptable.
- iii. A decision on the LOI is based on reviews by the CEPF Secretariat and the RIT. The CEPF Secretariat will aim to send a communication by no later than 20th April to let you know the recommendations of the CEPF evaluation process regarding your proposal.
- iv. If your LOI has been successful, the CEPF Secretariat will invite you to prepare a full project proposal in the ConservationGrants electronic portal. The detailed guidelines for preparing a full project proposal and contracting timeline will be provided with the letter of invitation.
- v. The RIT and CEPF Secretariat will work with the grant applicant to further orient the applicant in the submission of the final proposal, including the final budget. Completed proposal will lead to the award of a grant between Conservation International, as the host of the CEPF Secretariat, and the recipient (the "grantee"). The grant will be in US dollars and the grant agreement will be in English.

9. Criteria for Evaluation

CEPF will evaluate proposals based on the following criteria:

- i. Effective approach and timeline to meet the requirements of this Call for Letters of Inquiry.
- ii. Experience and qualifications in planning and coordinating similar regional meetings in the Solomon Islands in a short timeframe.
- iii. Demonstrated knowledge of policies and procedures specific to planning conferences for nongovernmental organizations or similar organizations.
- iv. Ability to provide full logistical conference support including, but not limited to, timely liaison and coordination with a designated travel agency and participants; timely and accurate production of conference materials; on-site conference management; and production of closeout materials (conference proceedings and summary).
- v. A cost-effective budget demonstrating: appropriate allocation of labor days in relation to tasks and deliverables; appropriate direct costs in relation to the scope of work; and overall cost effectiveness of travel, accommodation and venue costs. All budget lines should include unit costs.
- vi. Demonstrated communications and outreach experience with media outlets in the EMI hotspot, or capacity to procure such expertise.
- vii. References for similar work.
