- NTFP will deliver the online training/meetings/workshop via Apps such as Messenger or Facebook, which App that easy to use by the communities.
- Facial masks and sanitized materials (facial masks, alcoholic, and rappid) will be budgeted to distribute for the participants for any face to face meeting/training/workshop.
- Social distance is often practised in all meeting/training/workshop.
- Pushing staff to get boosting vaccination based on government instruction.
- Keeping the participants educated about the COVID 19 pandemic, mainly the variant ones.
