A management plan and a financial sustainability analysis will be designed in a participatory way together with the at least 50 communities and Shuar leaders trained. A baseline of trigger species for the KBA will be set up to begin monitoring. Articles about the importance of the Cordillera del Cóndor KBA will be produced and disseminated.

The project aims to have 200 local community members acknowledge the ecological value of the Kosñipata-Carabaya KBA and promote its conservation.
